Visa Requirements:

- Signed Passport valid for six months with at least one blank visa page.
- One visa application form (Two forms for Non U.S. Citizens) completed and signed.
- Two passport sized photos 2" x 2" ONLY.
- Invitation from Thailand with a company seal (For business visa).
- A letter of Financial Responsibility from your company in the U.S. (For business visa).
- Copy of flight itinerary from the travel agent of a copy of the tickets (U.S. Citizens are permitted in Thailand for 15 days without a visa)
- Copy of bank statement.
- Copy of Green Card (For Non-U.S. Citizens).

Validity of Visas:

- Tourist and Business visas are valid for 3 months from the date of issue for stays of 90 days.

Jurisdiction:

- Residents of all states can be processed in Washington DC.
